| TEAM UNIFORMS | <p>The organizer will not provide uniforms to the participating teams, and as a result the participating National Federations shall provide their players with minimum 2 sets of uniforms in different colors according to the layout specified in Annex 2 of the General EEVZA Age (U18-U16) Beach Volleyball Championship Regulations and may exploit them commercially (excluding the following product categories: alcohol (sprints), tobacco & pornography). Uniforms must be presented during the Preliminary Inquiry. National Federations/ Athletes are responsible to bring their own shorts/ bikini bottoms as per provisions of the CEV Beach Volleyball Regulations. | ACCOMMODATION, LODGING, TRANSPORTATION | <p>Accommodation will be arranged for the officially registered delegations and by the request of federations also for other members of official delegation. Local organizer one day before starting and one day ending of the competition will cover expenses of accommodation, lodging of official delegation, for other members, federations will pay by themselves. Information about amount of extra persons has to be sent to Organizer no later than 15 days before the starting of the competition.</p> <p>Federation of participating teams is responsible for their international travel and visa costs as well. Each team must organize its own travel to the official venue of arrival/departure indicated by the organizer of the event. The Organizer shall provide local transport from the official venue of arrival and departure to the hotel and back for the Officials, referees, players, coaches and other official delegations members. Waiver document

Given the ongoing COVID-19 Pandemic and the efforts made by the international community, CEV, EEVZA and the Local Organiser, important information are included in Practical Information documents of the EEVZA _____ Beach Volleyball Championship 2021 tournament regarding the EEVZA Hygiene protocols plus the National and local regulations in place during the period of the event.

EEVZA wants to ensure that all of its stakeholders have all of the necessary information related to COVID-19 and has taken steps to minimize the potential risk of COVID-19. However, the EEVZA notes that a risk of COVID-19 still exists despite all efforts.

With the information provided in the Practical Information documents, on EEVZA and National Authorities websites, we would like to inform you of the possible risks involved in this Tournament 2021 event that includes the travel to and from the event. You are participating in your own free will and you are aware of and assume the possible risks related to the COVID-19 by participating in this event.

To be specific, by acknowledging this document and continuing to participate in the event after receiving it as part of Practical Information document, you are aware and agree that:

1. While the local protocols and personal discipline may reduce this risk, the risk still does exist; accordingly, your participation includes possible exposure to and illness from infectious diseases, including but not limited to COVID-19; and,
2. You knowingly and freely assume all such risks, both known and unknown, even if arising from the event and assume full responsibility for his/her participation in this event; and,
3. You willingly agree to comply with the **EEVZA Competitions Hygiene Guidelines, the local protocols and requirements in place in and outside the venue (imposed by National Federations Government for events organizing)**. If, however, you observe any unusual or significant hazards during the player presence or participation, you may remove yourself from the event and participation; and,
4. You, hereby release and hold harmless the EEVZA and the event organizers and organizing National Federation, including officials, delegates, sponsors, staff, volunteers

and other players with respect to any and all illness, disability or loss/damage to the player's person or property, whether arising from the negligence of the releases or otherwise, to the fullest extent permitted by law.

5. Organizer of the event will cover all medical & accommodation expenses if diagnosed with Covid-19 infection on site.

We kindly ask that you reflect on the above and take the time to seriously consider the implications of the above on you and your families before taking a decision as to whether you wish to participate.

If you agree with the above points, you are kindly required to duly sign this document. If you do not agree on the conditions and you are not signing the agreement, this will result in your immediate withdrawal from the event.
